#### **Best Research Award Regulations**

# [Regulations and Guidelines for Best Researchers Award]

#### 1. Name of the Award

The Best Researcher Award of Jagan Nath University, Bahadurgarh.

## 2. Objectives

- (a) To recognize outstanding researcher from Jagan Nath University.
- (b) To provide incentives for excellence in research and innovation made by a faculty member or a student of the University.

## 3. The Year of Research Work to be Recognized

An academic year, 1st July of preceding year to the 30th June of the year of the award.

## 4. Frequency

The frequency of the award is annual.

# 5. Eligibility Criteria

- (a) The best research paper published in a reputed International/National Journal having high impact factor by a faculty member or a student of the University.
- (b) The research work publication must be original and well-focused on an important theme.
- (c) The award is meant for individuals for their extraordinary, original creative contributions in advancement of knowledge, concept, new technology, innovation, prototype, software, etc.

#### 6. Evaluation for the Award

- (a) There shall be a Judging Committee of 3 members including the Chairperson to evaluate the applications and make appropriate recommendations to the Vice-Chancellor.
- (b) The Judging Committee will be appointed by the Vice-Chancellor in consultation with the Chancellor.
- (c) The recommendations of the Judging Committee shall be placed before the Academic Council and thereafter before the Board of Management for consideration and a final decision.

#### 7. Evaluation Criteria

- Conceptual clarity and originality of the research work.
- Scientific, technological and socio-economic relevance.
- Significant knowledge generation in Science, Technology, Management, Law, Architecture, etc.
- Quality of research publication as evidenced by its impact factor.
- Practical impact and utility of Research work done.
- Any other criteria as the Judging Committee deems it necessary.

## 8. Screening, etc. for Award

- (a) The Judging Committee will screen the applications received and will make appropriate recommendations along with the draft citation to the Vice-Chancellor who will place them before the Academic Council and Board of Management for consideration and final decision.
- (b) In case no outstanding entries have been identified, no award will be given.
- (c) In case of multiple authorship, only the first author will be awarded. Other can be given certificates only.
- (d) The decision of the committee after the approval of the Board of Management would be final and binding and no representation would be entertained.
- (e) The respective Deans/HODs of different Faculties of the University would be forwarding applications certifying that the research work is carried out at their Faculty.

#### 9. Presentation of the Award

The presentation of the ward will be made in the Convocation each year. The award would carry a cash prize of Rs. 11,000/- with a citation and a certificate.
