**Sub: Extension of approval of affiliation to Faculty of Legal Education, Jagannath University, Jhajjar, Haryana for imparting five year BA LL.B (Hons.) law course with an intake of two sections of 60 students in each section.**

Sir,

Legal Education Committee at its meeting held on **30<sup>th</sup> July, 2016** considered the above mentioned subject. After consideration, Committee made the following recommendations: -

The Legal Education Committee considered the inspection report submitted by the inspection team. After consideration, Committee is of the view that **Institute of Law, Faculty of Legal Education, Jagannath University, Jhajjar, Haryana** be granted **extension of approval of affiliation for imparting BA LL.B (Hons.) five year course** with an intake of **two sections** of 60 students in each section for a period of **three years** i.e. for the academic years 2016-2017, 2017-2018 and 2018-2019

College authorities are also required to apply to the Bar Council of India for further extension of approval six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2018 in respect of five year BA LL.B (Hons.) law course.

The above recommendations were considered by the Bar Council of India at its meeting held on 13<sup>th</sup> August, 2016 and approved the same.
